Venue- Conference room, ASA Jaipur


1. The meeting started with a welcome note by the Chairman
2. Outreach Activities: The status of current collaboration with institutions and Professional bodies was presented by Prof. Naveen Sharma, Incharge outreach and consultancy. It was discussed to seek collaborations with professional bodies like: ISHRAE, ASHRAE, ISLE to enhance knowledge of contemporary technology etc. It was also directed to renew the institutional MOU with foreign Institutions.

2A: Further, house was appraised that Aayojan is committed towards enhancement of professional competency of students and faculty, in line with this vision, Aayojan Centre of Excellence has made representations to following departments :

- a) Rajasthan housing Board
- b) Jaipur Development Authority
- c) Jaipur Nagar Nigam (Greater and Heritage)
- d) North western Railways
- e) Urban Development and housing department.
- f) Department Local self governance
- g) Town Planning Department
- h) PDCOR
- i) Department of Archaeology. GOR

2B: House has also informed that as per the directions of UNESCO regarding the title of World Heritage City for the walled city of Jaipur, it is required to prepare the special area plan for the walled city.

Aayojan was awarded the work order for survey works of this plan, where architectural interns along with a team of three faculty members were appointed to work under the mentorship of Dean. The duration of this project shall be for 7 months.



- 2C: It is deliberated to further reach out to the alumni of the college. The IQAC coordinator mentioned that the institute is committed to recognising the achievements of its alumni through social media and appreciating them by inviting them to college for guest lectures, soft skill development, entrepreneurship development etc. Efforts were appreciated by the house and HOD's of all respective departments were also suggested to ensure the continuation of such recognitions.
3. IIQA Status: The NAAC coordinator appraised the house that IIQA was submitted in December 2023. IIQA application was rejected due to the absence of, University affiliation letter for AY 2023-24. The same letter was asked from Rajasthan Technical University. The letter was received stating that the affiliation for the year 2023-24 is still under process. The letter was uploaded but it was not considered equivalent to the affiliation letter, therefore NAAC has rejected our IIQA.
4. CO/PO attainment: Progress of CO/PO attainment: The Dean's presentation highlighted that a significant proportion of courses have successfully achieved their targeted COs. Student performance metrics, such as exam results and project outcomes, have reflected this. Courses that adopted interactive and project-based learning methods showed higher CO attainment levels. Several courses were mapped to the overall POs, demonstrating how individual course achievements contribute to broader program goals. For instance, courses focusing on practical applications were shown to align closely with POs related to critical thinking, problem-solving, and creative design skills. Despite the overall positive attainment, some gaps were identified, particularly in courses that require interdisciplinary integration. The assessment revealed that some inconsistencies in teaching methods led to variability in CO attainment across different sections of the same course.
5. Course audit feedback: The Dean informed the house based on the insights gathered from course exit surveys. Some gaps in the curriculum were realized, such as topics that needed more coverage or areas where students struggled to meet learning objectives. This feedback was instrumental in refining course content and structure to better assist students in meeting the COs.
